Staff acted on behalf of the Commission to request a supplemental information report, due August 1, 2017, addressing the Accreditation Council for Occupational Therapy Education (ACOTE)'s recent action. The next evaluation visit is scheduled for 2023-2024.

November 17, 2016

To accept the supplemental information report. To request a progress report, due April 1, 2017, documenting the status of students enrolled at the discontinued additional locations (Standard 13). The next evaluation visit is scheduled for 2023-2024.

August 8, 2016

Staff acted on behalf of the Commission to request a supplemental information report, due September 1, 2016, addressing recent developments at the College which may have implications for current and future compliance with Standard 5 (Administration), Standard 6 (Integrity), Standard 11 (Educational Offerings), and Standard 13 (Related Educational Activities).

November 19, 2015

To accept the monitoring report and to note the visit by the Commission's representatives. To remove the warning because the institution is now in compliance with Standard 7 (Institutional Assessment) and Standard 14 (Assessment of Student Learning) and to reaffirm accreditation. To request a progress report, due April 1, 2017, documenting further implementation of an organized and sustained assessment process for institutional effectiveness and

student learning that: (1) includes use of direct measures; (2) is used to evaluate and improve programs, services and processes; (3) provides convincing evidence that students are achieving key learning outcomes; and (4) integrates assessment results into planning, budgeting and resource allocation decisions. (Standards 7 and 14). The Periodic Review Report is now due June 1, 2020.

March 5, 2015

To note the visit by the Commission's representative. To remind the institution that it has been warned that its accreditation may be in jeopardy because of insufficient evidence that the institution is in compliance with Standard 7 (Institutional Assessment) and Standard 14 (Assessment of Student Learning). To note that the institution remains accredited while on warning. To request a monitoring report, due September 1, 2015, documenting that the institution has achieved and can sustain compliance with Standards 7 and 14, including but not limited to the development and implementation of a comprehensive, organized and sustained institutional assessment process that (a) is used for planning and resource allocation; (b) provides evidence that assessment results are shared and discussed with appropriate constituents and used for institutional renewal; and (c) includes periodic evaluation of the effectiveness and comprehensiveness of the assessment process (Standard 7); and an organized and sustained assessment process to evaluate and improve student learning across all programs and modes of delivery, with assessment results that are shared and discussed with appropriate constituents (Standard 14). A small team visit will follow submission of the monitoring report. The due date for the Periodic Review Report will be established when accreditation is reaffirmed.

November 20, 2014

To warn the institution that its accreditation may be in jeopardy because of insufficient evidence that the institution is currently in compliance with Standard 7 (Institutional Assessment) and Standard 14 (Assessment of Student Learning). To note that the institution remains accredited while on warning. To request a monitoring report, due September 1, 2015, documenting that the institution has achieved and can sustain compliance with Standards 7 and 14, including but not limited to the development and implementation of a comprehensive, organized and sustained institutional assessment process that (a) is used for planning and resource allocation; (b) provides evidence that assessment results are shared and discussed with appropriate constituents and used for institutional renewal; and (c) includes periodic evaluation of the effectiveness and comprehensiveness of the assessment process (Standard 7); and an organized and sustained assessment process to evaluate and improve

student learning across all programs and modes of delivery, with assessment results that are shared and discussed with appropriate constituents (Standard 14). A small team visit will follow submission of the monitoring report. To direct a prompt liaison guidance visit to discuss the Commission's expectations. The due date for the Periodic Review Report will be established when accreditation is reaffirmed.

May 1, 2012

To acknowledge receipt of the substantive change request. To note the institution's decision to close the additional location at White Plains Campus, 277 Martine Avenue, White Plains, NY 10601. The commission requires written notification within thirty days of the closure of this additional location. The next evaluation visit is scheduled for 2013-2014.

June 23, 2011

To thank the institution for receiving the Commission's representative and to affirm the inclusion of the additional locations at the Austrian-American Educational Cooperation Association, Mayerhofgasse 6, A-1040 Vienna, Austria and Pedagogische Hochsule-Wien, Grenzackerstrasse 18, 1100 Vienna, Austria within the scope of the institution's accreditation. The next evaluation visit is scheduled for 2013-2014.

May 5, 2011

To acknowledge receipt of the substantive change request and to include the additional locations at the Austrian-American Educational Cooperation Association, Mayerhofgasse 6, A-1040 Vienna, Austria and Pedagogische Hochshule - Wien, Grenzackerstrasse 18, 1100 Vienna, Austria provisionally within the scope of the institution's accreditation pending a site visit within six months of commencing operations at one of the sites. The Commission requires written notification within thirty days of the commencement of operations at this additional location. In the event that operations at this additional location do not commence within one calendar year from the approval of this action, approval will lapse. The next evaluation visit is scheduled for 2013-2014.

Information about the Middle States Commission on Higher Education

The Middle States Commission on Higher Education (MSCHE) is one of seven institutional accrediting organizations in the United States and is recognized by the U.S. Secretary of Education and the Council for Higher Education Accreditation (CHEA). MSCHE accreditation applies to an institution as a whole rather than the specific programs within an institution. MSCHE does not approve or accredit individual programs. The MSCHE accreditation review cycle is continuous and accreditation does not expire. Each institution is reevaluated and monitored on a regular and consistent basis in accordance with the institution's assigned accreditation review cycle and Commission policy and procedures. An institution maintains its accreditation unless it is voluntarily surrendered or withdrawn by the Commission for cause, after the institution has been afforded due process. The institution's current accreditation phase and accreditation status are displayed on the institution's listing in the Institution Directory and in the Statement of Accreditation Status (SAS).
