Graduates of the program are eligible apply for STATE certification as a veterinary technologist. In order to practice as a Veterinary Technologist in Puerto Rico, graduates must take the Puerto Rico Veterinary Technology Board Test, offered by Junta Examinadora de Médicos Veterinarios de Puerto Rico. Graduates may also take the Veterinary Technician National Examination, VTNE. *VTNE is not required to practice veterinary technology in Puerto Rico.

State/Territory	Professional Licensing Board
District of Columbia	DC Board of Veterinary Examiners - District of Columbia does not presently require veterinary technologists to be licensed or certified. Graduates of the Mercy College’s Bachelor of Science Program in Veterinary Technology are eligible to work in the District of Columbia.
Utah	The State of Utah does not presently require veterinary technologists to be licensed. A veterinary technologist who has graduated from a four-year program of veterinary technology accredited by the AVMA and is working under indirect supervision is eligible for state certification. Graduates of the Mercy College’s Bachelor of Science Program in Veterinary Technology are eligible to work in Utah.
